TERMS OF REFERENCE

1. BACKGROUND

The Nelson Mandela Museum (NMM) is a not for profit institution established by the government of South Africa as an agency of the National Department of Sports, Arts and Culture. It was established as part of a portfolio of legacy projects that seek to transform the heritage landscape from our apartheid past. At the same time, it is a resource for promoting economic development through tourism in an impoverished region of the country. The museum primarily houses collections of gifts to the nation given by Nelson Mandela to the museum to share his legacy with the nation.

The mandate of the Nelson Mandela Museum is to preserve and promote the legacy of Nelson Mandela, and one of its main strategic goals is to improve the museum's public profile and access. This mandate is executed through the museum's two main facilities, the Qunu Youth and Heritage Centre, and the Bhunga Building in Mthatha CBD. The Bhunga Building doubles as the administrative office of the museum.

2. **PURPOSE**

The Nelson Mandela Museum intends to appoint a reputable service provider to host the NMM website for a period of five (5) years. Prospective service providers are advised to go through the existing NMM website to have an understanding of the magnitude and diversity of information collected and hosted on this website.

3. **PROJECT BACKGROUND**

The current Nelson Mandela Museum website has been redesigned, developed and completed in last year, 2023. The service provider to be appointed must host as well as support as well the NMM website must adopt the already existing interface and provide long-term hosting, maintenance, support in WordPress.

The Nelson Mandela Museum will require full access to the website, content maintenance and administration. NMM IT specialist will have super-admin rights (be able to add, edit and/or delete users, assign roles to users). All content, coding, graphics and design will remain the sole property of Nelson Mandela Museum.

To be considered, candidates must be able to:

- Be able to implement new features in recommended CMS
- Be able to bug fix any current issues
- Host the server on a secure and stable server
- Be able to provide around the clock support
- Maintain and update the recommended CMS framework and modules

4. **SCOPE OF WORK**

- The service provider shall host the NMM website for a period of five (5) years.

4.2 Hosting

The hosting services requirements are as follows:

4.2.1. Provision of secured managed cloud hosting environment with a premium antivirus software.

4.2.2 Dedicated server hosting fully managed – including monitoring, software updates, reboots, security patches, antivirus, and operating system upgrades,

4.2.3 Hosting of production live, failover sites and pre-production (test) environment

4.2.4 Response to incidents

- Incidents are considered to be either of critical or medium severity.

4.2.4.1 Incidents of critical severity

i). non-availability of site

ii). data loss

iii). issues related to the confidentiality/security of data

iv). problems preventing users to access key functionality, including preventing them from doing their daily work.

4.3.4.1. The above incidents must be resolved within 1 hour mean time to respond and 2 hours mean time to repair.

4.3.4.2 Incidents of medium severity

Incidents of medium severity which do not fall under the previous category must be resolved within 72 hours of the problem being reported.

4.3.6 Backups and Restore

Ensure that all data is backed and provided to the NMM for record-keeping every month. The creation of a test environment for both websites is required. The contractor should test backups regularly by testing the backup restore procedure. The contractor should report about the success or failure of these tests in monthly reports.

4.3.7 Licenses

The NMM has its own Microsoft 365 license. It is the responsibility of the service provider to ensure that all license requirements for the hosting platforms are fulfilled. The cost of any licenses must be included in the pricing schedule.

- NMM may require responsive bidders to present and discuss their proposals in person.
- NMM reserves the right not to make any appointment from the proposals submitted.
- Bidders shall not issue any press release or other public announcement pertaining to details of their project proposal without the prior written approval of NMM.
- Bidders are required to declare any conflict of interest they may have in the transaction for which the bid is submitted or any potential conflict of interest. It is important that bidders declare their conflict of interest through completion of relevant attached forms.
- NMM reserves the right not to consider further any bid where such a conflict of interest exists or where such potential conflict of interest may arise.
- Any and all project proposals shall become the property of NMM and shall not be returned.
- The bid offers and proposals should be valid and open for acceptance by NMM for a period of 120 days from the date of submission.
- NMM reserves the right not to award the bid to the bidder that scores the highest points. Disputes that may arise between NMM and a bidder must be settled by means of mutual

consultation, mediation (with or without legal representation) or, when unsuccessful, in a South African court of law.

- In addition to adherence to the specific terms and conditions of proposals, provided in this document, the bidder shall be bound by the provisions of the General Conditions of Contract, an original signed copy of which must be submitted together with all other bid documentation.
- After the successful service provider has received the appointment letter, they must be able to deliver in full compliance with South African approved standards and in compliance to the specifications provided

- The NMM reserves the right by giving written notice to the service provider to stop the works' progress at any time. Should the client exercise this right, the NMM will pay the service provider for work done and expenses incurred only up to the time that the notice was given.

10. EVALUATION CRITERIA

Criterion 1- Compulsory Requirements

Bidders will first be evaluated in terms of the gatekeeper/minimum requirements stipulated. Bidders who do not fulfil all the requirements or do not submit the required documents will be disqualified. Those who fulfil all the requirements or have submitted the required documents will be further evaluated on functionality.

Criterion 2- Functionality

Functionality is worth 100 points. The **minimum threshold is 70 points**. Bidders who score less than 60 points on functionality will therefore not be evaluated further. Those who score 60 points or more will be evaluated in terms of price and preference points (points allocated for specific goals). The functionality evaluation is broken down as follows:
