The Nelson Mandela Museum (NMM) invites quotations from accredited service providers that are registered with the Central Supplier Database (CSD) to offer payroll services at the Nelson Mandela.

➤ **SCOPE OF WORK**

Nelson Mandela Museum is looking for suitable service provider to provide payroll services which will ensure accurate and timely processing of employee salaries, benefits and deductions while complying with relevant laws and regulations. This service provider will handle various aspects of the payroll management system, including salary calculations, tax deductions, benefits administration and statutory compliance. They also maintain employee records, generate payroll reports and ensure financial confidentiality.

The service provider will also be instrumental in maintaining strong relationships with employees, finance departments and external stakeholders such as tax authorities and regulatory bodies. The service provider must possess in-depth knowledge of payroll systems, accounting principles, labour laws and taxation requirements.

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
