HUMAN RIGHTS ESSAY COMPETITION TOP TEN WINNERS

QUNU, MTHATHA - The Nelson Mandela Museum made a call for Grade 10 and Grade 11 learners to submit Essays for its Annual Human Rights Essay Competition. The program encourages Grade 10 and 11 learners to showcase their writing abilities, knowledge, and engagement on the subject, presentation, and public speaking abilities.

This year's program saw more than seven hundred applicants from nine provinces of South Africa submitting their essays. This year's essay topic," You are a student at school X, but owing to your sexual orientation, you feel discriminated against, and your human rights as enshrined in the constitution are trampled by other learners and educators," resonated with high school learners from across South Africa.

The essays were adjudicated by independent judges from Walter Sisulu University and the Department of Basic Education, who have looked at all submissions, which saw 100 essays advancing to the next stage. After a rigorous selection process, the top finalists were chosen. The top ten competitors will be vying for the top three positions. On the 13th of March 2025. they will be doing oral presentations at the Nelson Mandela Museum Youth and Heritage Centre in Qunu.

The Nelson Mandela Museum Communication unit caught up with

the top ten to find out about their feelings on making the top ten;



Marungula Nkuna Said," To be honest, I was a bit anxious when I started writing the essay. I felt overwhelmed by the complexity of the topic, but as I researched, I realised the importance of creating a safe and inclusive environment, and was struck by the alarming statistics on bullying and harassment.

"I structured my arguments using legal instruments, which include the South African constitutional framework, international human rights law, and domestic legislation, hoping to contribute to a greater understanding and inspire change for good.

"I wouldn't say I had a thorough understanding of the topic before starting the essay, but I had some general knowledge about some of the legal instruments used to protect the rights of sexual oriented learners. Despite this, through research and writing the essay, I gained a deeper understanding.

Tshegofatso Selemela's from Sol Plaatje Secondary in Mahikeng, North West said, "Before I started with the essay, I aimed to make it as genuine and truthful as possible, and I knew that if I wrote as a homosexual learner, I would not achieve my aim because I am not. So, I decided to write my truth, being a heterosexual learner and some of the things that I experienced.

"When I was writing this essay, I had doubts because I was writing about an unpopular idea that doesn't get reported when it happens, as it doesn't seem very valid. After all, such things are believed only to happen to people of the LGBTQI+ community. However, I put my doubts aside and continued, hoping to shed some light on this constantly hidden experience, so I did.

"I believe I did have a thorough understanding and knowledge of the topic. I was requested to write about the discrimination, challenges, and experiences I faced because of my sexual orientation at school. Not only this, but I was also requested to support my concerns with some laws in our Constitution, mainly focusing on the Human Rights Laws, which I believe I did exactly that.

"I was overwhelmed and happy. I was not expecting to be selected as I wrote about a very unpopular opinion and took a great risk, but was happy when I did get selected. My teacher expressed that it was a great and overwhelming feeling for me to be selected out of a hundred (probably a thousand participants). She is proud of me and says that it shows that hard work and effort will always reap good results.

"Honestly, a person can never be too ready. I am nervous, but I know that as long as I am determined and I have God, I can do anything". **End**



Motebele Ramokone, Noordwyk SSS from Gauteng said, "In the beginning I was clueless about what I could write

about since the topic was about me being discriminated because of my sexual orientation. In the process of writing my essay, one thing that I was sure about was that I wanted to make a difference. To be able to make people understand about the emotions and pain that other people have to go through because of how their sexual orientation is seen in the eyes of the public and society.

"When this topic was introduced to us (learners), it was a bit challenging and confusing. I did not understand what was expected from us as I have never encountered such an issue. As much as I have never encountered this, I knew that there might be a possibility of other learners who are experiencing ill-treatment in our schools.

"Ma'am Ntshingila, who is my teacher, did explain to us that her explanation and interpretation of the topic brought some light. I further got assistance from my English teacher Mr Mashao, my father, and Nduvho who is a previous learner at our school. Their assistance gave me confidence and understanding of how I can write this essay.

"After getting the amazing news, I was so happy. I had a lot of mixed emotions running in my heart. At that time, I was so grateful that all my hard work paid off. Both my teachers and my parents were so proud of me.

"My parents were happy, and proud that their daughter made it to the top 10. Both the school and my family encouraged me to keep going and keep fighting for those whose voices are not heard.

"I intend to make my province proud and shine a light in these challenges we are facing because it may be just an essay competition to some, but there is someone who is living through this.
